## Terms, Additional Services and Discounts:

- Family discount: 2 or more campers, deduct 5%.
- Pay in full before March 15, 2010 and deduct 3%.
- **All fees are due by May 15, 2010.**
- If Bible Camp is the only program for which you are registering, the fee is a flat \$95 per camper. None of the above referenced discounts apply to a Bible Camp only registration.
- \$25 Administration fee will be charged for cancellations after April 15, 2010. Camp fees are non-refundable after May 15, 2010.
- **No camp** Monday, July 5.

## Friday Opt-Out:

This option is for families who prefer long summer weekends for cabin trips, etc... Opt-Out gives all Fridays off except 7/16 (Variety Show) and 8/13 (last day celebration). Friday Opt-Out option is **only available for campers in Traditional and Kindergarten Camps.**

## Overnight Camp-Outs:

One overnight is included for all Traditional campers (4-6 grade) and Middle School campers (excluding campers in session B & 6). Traditional camp overnights will occur on Thursday, July 8 and Thursday, August 5.

## Parent/Guardian Agreement:

**FEES:** ALL payments are due by May 15, 2010.

**REFUNDS:** The deposit, which is applied to the camp fee, is non-refundable after May 15, 2010. Other payments are non-refundable except in cases of extended illness or accident.

**ABSENCES:** No reimbursement will be available for absences, however, we will pro-rate 1 week equivalent\* off and credit 80% of your camp fees for that week if you let us know what dates your child will be absent **before March 15, 2010**. (\*for session #1, 1 week equivalent is 5 days, for session #2-5, 1 week equivalent is 3 days).

**ACCIDENTS / ILLNESS:** In the event that a child is hurt at the camp and needs emergency treatment or becomes ill and unable to participate in the camp program, the staff will try to reach the camper's parents, emergency contacts, or the family physician. Costs incurred by injury/illness are the responsibility of the parent/guardian and their health insurance.

**ACTIVITY PARTICIPATION:** While this camp is operated on the highest safety standards, we do not assume liability for sickness, disease or accidents. Children will be gently encouraged to participate in supervised activities such as the following: swimming, horseback riding, camping, canoeing, tennis, bike riding, art, crafts, science, outdoor sports, animal care, drama, climbing wall, archery, and other activities not listed but appropriate to the environment at Hidden Pines Ranch. A signed letter or completion of the "Activities Restrictions" section of the Health and Medical Information form is required if parents wish a child to be excluded from a specific activity.

**LOST AND FOUND:** Everything brought to camp should be marked with a name. Items not needed at camp should be left at home. The camp is not responsible for lost, stolen or broken articles.

**PICTURES:** Your signature on this Parent/Guardian Agreement form will be considered permission to use pictures taken of your child at camp in our newsletters, brochures, exhibits, web site, online photo album and other advertising materials.

**DISMISSAL:** For the protection of your child's interests, we reserve the right to dismiss or suspend any camper whose influence is not positive to the camp environment.

**FIELD TRIPS:** As part of any of our programs at Hidden Pines Ranch, we may from time to time have the opportunity to take campers off-site for a field trip. For example, Traditional Campers may take a hike or bike ride off-site, and/or they may be invited to enjoy a hard-earned canoe trip. We will give you prior notice of the times, dates and destinations of your child(ren)'s specific field trips. By signing this agreement, you give your child(ren) permission to leave the Hidden Pines Ranch property for trips/excursions taken as part of our camp programs. Transportation (excluding bike trips/hikes) will be via Hidden Pines Ranch vans, and American Camping Association standards will be followed, with your child(ren)'s safety as our highest priority.

**RELEASE OF CLAIMS:** In consideration of the permission granted to my child by Hidden Pines Ranch, Inc. to participate in the various activities of the camp, the undersigned parent/guardian hereby releases Hidden Pines Ranch, Inc., its agents and employees from all actions, causes of action, damages, claims, or demands which I, my heirs, executors, administrators, or assigns may have against Hidden Pines Ranch, Inc., and other above-described parties for all personal injuries known or unknown which my child has or may incur by participating in the camp activities.
